## BASIC PACKAGE

The purchaser agrees to the following: The Basic Package has been chosen. The package includes thirty minutes prior to the ceremony, the ceremony itself and coverage of the couple leaving for the reception. This package also includes 2.5 hours of the reception. Additional coverage, if requested, runs \$50.00 per hour per operator. A wireless mic is provided. A non-refundable deposit of \$100.00 is to be paid to Davis Video Productions prior to the wedding day to reserve videography services for the date listed above. Deposits are honored on a first-come, first-serve basis. The balance is due prior to, or on, the day of the wedding. Three DVD-Rs are included in the Basic Package. Extra copies run \$15.00 each + any applicable sales tax & shipping. If in the event the wedding is canceled or rescheduled for any reason, funds already paid to Davis Video Productions towards the package will not be refunded. Davis Video Productions will accommodate a rescheduled wedding only if the purchaser's new date does not conflict with that of another DVP customer. The purchaser will allow any and all shooting, editing and artistic techniques used in the video to be the discretion of Davis Video Productions. The time included in this package is the time Davis Video Productions is on site and not necessarily reflective of the total length of footage shot on the wedding day. A rental car fee may be charged for weddings beyond 25 miles of Pinehurst, North Carolina. Hotel accommodations may be charged to the purchaser if an overnight stay is necessary. The purchaser shall release Davis Video Productions from any and all financial, videography and/or travel obligations related to the wedding in the event that DVP experiences severe weather, medical emergency, mechanical breakdown or unforeseen travel delays on the day of the wedding. Wedding footage may be used for promotional purposes.
